Call to Order: Chairman John Murdock called the meeting of the town of Mount Pleasant Planning and Zoning Board to order at 7:00 pm. Chairman Murdock recognized Rick Burleyson as having full voting privileges due to Jeff Helmintoller being absent.

Recognition of Quorum: Chairman Murdock stated a quorum was present.

Election of Chair and Vice-Chair:

Chairman John Murdock entertained a motion for nomination of Chairman of the Planning and Zoning Board for 2015-2016. Mike Steiner nominated John Murdock to remain as Chair. Members voted by acclamation and vote was unanimous.

Chairman John Murdock entertained a motion for Vice-Chair of the Planning and Zoning Board for 2015-2016. Rick Burleyson nominated Whit Moose to remain as Vice-chair. Members voted by acclamation and vote was unanimous.

Approval of Minutes: Motion was made by Whit Moose to approve the minutes. Second was made by Shirley Freeman. All members (5-0) were in favor.

Approval of Agenda: Chairman Murdock entertained a motion to approve the Agenda. Motion was by Mike Steiner, and second was made by Whit Moose. All members (5-0) were in favor.

Planning Board Case: 2015-ZTA-01 - Continued...

Request by the Town of Mount Pleasant Board of Commissioners to amend the *Unified Development Ordinance* to include language about LED displays within the Town's Zoning Jurisdiction.

Mr. Goodall reviewed the June 2015 discussion and highlighted the following changes to the original amendment; in the definitions section LCD was changed to LED, the shut-off time for the LED displays was changed from 11:00PM to 10:00PM and Changeable Copy signs, including LED displays were removed from CC/TC zoning districts. Whit Moose confirmed that LED displays would not be permitted in the downtown area. Mr. Goodall confirmed. Chairman Murdock entertained a motion to

New Business: Planning and Zoning Board meeting time/day

Randy Holloway, Town Administrator addressed the Board asking Planning and Zoning if they would be willing to change meeting time from 5 pm to 6 pm and if they would consider moving from 2nd Monday in the Month to another Monday enabling the Town Administrative Board to move its meeting from the first Monday to the second Monday. Planning and Zoning Board members looked at individual schedules and asked to move to the 3rd Monday or Tuesday in the month at 6 pm. Mr. Holloway will bring before the Town Administrative Board at the August 31 meeting. Changes would most likely begin in January 2016 to both boards' meeting times.

Staff Reports: Mr. Goodall commented Barringer's Trace should begin moving dirt around September 1. Mr. Goodall reported the second building at the Family Dollar Center ran into a few snags. The front of the building did not match what was approved on plans. There are many changes to the structure needed to meet ordinance requirements, and Mr. Goodall and Vagn Hansen are working toward resolutions. Code Enforcement in the Town is ongoing. Lot at corner of Skyland Drive is still for sale.
