Call to Order: Chairman John Murdock called the meeting of the town of Mount Pleasant Planning and Zoning Board to order at 7:00 pm.

Recognition of Quorum: Chairman Murdock stated a quorum was present.

Approval of Minutes: Motion was made by Whit Moose to approve the minutes. Second was made by Jeff Helmintoller. All members (5-0) were in favor.

Approval of Agenda: Chairman Murdock entertained a motion to amend and approve the agenda adding Town Administrator, Randy Holloway, giving an update on the Water Rate increase for the Town of Mount Pleasant. Mike Steiner made the motion to approve the amended agenda. Second by Whit Moose. All members (5-0) were in favor.

Public Comment: None

Update on Water Rate Increase: Randy Holloway, Town Administrator, gave an update on how the approved rate increase will effect in-town and out-of-town residents. Rate increase will be effective July 1, 2015. Mr. Holloway also shared the Town is exploring options for resolution to WSACC's operating losses from the past eleven years from the Mt. Pleasant water treatment facility.

Planning Board Case: 2015-ZTA-01

Request by the Town of Mount Pleasant Board of Commissioners to amend the *Unified Development Ordinance* to include language about LED displays within the Town's Zoning Jurisdiction.

After much discussion, Mike Steiner made a motion to table discussions until the July meeting with a second by Chairman Murdock. Planning and Zoning Clerk, Crystal Smith, asked if the Planning Board will meet in July as, in the past, there has not been a Town Board meeting or a Planning Board meeting in July. Chairman Murdock then entertained a motion to cancel the July meeting and have further discussion on LED UDO amendment in August.
